

Terms and Conditions

The following would be the general terms and conditions of the “Study in India” testimonial video competition:

1. The “Study in India” testimonial video competition is being conducted by EdCIL (India) Ltd. for “Study in India” programme under the aegis of Ministry of Human Resource Development (MHRD), Government of India.
2. The promoter of this competition is EdCIL (India) Ltd. (“Promoter”)
3. Entry into the competition is free.
4. To enter this competition, a participant must be an individual holding a passport issued by any country other than India and should be either enrolled or have completed a course from an Indian educational institute recognized by MHRD as on 30th May 2019.
5. To enter the competition, participants must produce a video entry of no less than thirty (30) seconds and no longer than seventy five (75) seconds in duration, which gives an account of their experience of studying in India and how it has impacted their life.
6. The video must be original and should not violate any provision of the Indian Copyright Act, 1957. It should only include original material(s) created by the participant, including (where applicable) any words, art, music, photographs, sound recordings or film footage.
7. Plagiarism/copying of any nature would not be allowed. Any participant found infringing on others' copyright would be disqualified from the competition. EdCIL does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
8. The video must not contain any provocative, objectionable or inappropriate content. If such content is found, the video will be disqualified from the competition.
9. It is a condition of entry to the competition that the work submitted by the participant must be in English language
10. The participants need to fill out the registration form & upload their videos on the website <https://contest.studyinindia.gov.in/contest>
11. The participants also need to upload a scanned copy of their passport / citizenship card and university’s identity card
12. Participants should upload the video in one of the following formats only:
 - a. .MOV
 - b. .MP4

- c. .MPG
- d. .WMV
- e. .AVI
- f. .MPEG4

13. The video(s) submitted by the participant(s) would be validated by the Promoter
14. Post the above validation, participants will be notified via email regarding the approval/rejection of their video
15. The participants whose video has been approved will also get details about posting the video on their respective Facebook accounts (using relevant hashtags)
16. The participants need to follow the above procedure to share the approved video on their facebook accounts.
17. The promoter will re-validate the videos of all participants at the end of the competition. If any discrepancies are found between the originally submitted video to the Promoter & the video uploaded to the Facebook account, then that participant will be disqualified from the competition.
18. The evaluation criteria for the competition will be as follows:

Parameters	Weightage
Content, quality & creativity	75%
1 point for every “like” received on facebook	25%
5 points for every “share” received from facebook	

19. The participant whose work has received the highest score after considering all the evaluation criteria will win prize money of INR 50,000/-. The first and second runner up would get prize money of INR 30,000/- and INR 20,000/- respectively.
20. Multiple entries are not allowed and participants found guilty of sharing multiple videos will be disqualified
21. Submission of videos will start on 23rd May 2019 and will end on 31st July 2019. Promoter will consider the “likes” & “shares” received till 11:59 pm on 15th August 2019 as the final scores for each participant.
22. The results for the competition will be declared by the last week of August 2019 on the website and the official Facebook page of Study in India.
23. The promoter reserves the right to cancel or amend all or any part of the competition and/or the terms & conditions/evaluation criteria. However, any changes to the terms &

conditions/evaluation criteria, or cancellation of the competition, will be updated/posted on the Study in India Facebook page (<https://www.facebook.com/studyinindiagov/>) and website (<https://contest.studyinindia.gov.in/contest>). Participants are responsible to keep themselves informed as to any changes in the terms & conditions/evaluation criteria stated for this competition.

24. The participants represent and warrant that they will comply with all applicable Indian laws. The participants shall not disclose and/or use any information, if doing so is in violation of any obligation against confidentiality.
25. By submitting their work to the Promoter, the participants grant the Promoter and its licensees and assignees a non-exclusive, irrevocable, royalty-free license to exercise all rights in perpetuity throughout the world in the participants' work and all other material(s)/information provided by the participants to the Promoter pursuant to this competition at any time. Participants' work(s) may be edited or adapted at any time by the Promoter.
26. The participants warrant that:
 - a. all details provided with their entry are true and accurate;
 - b. they have all necessary rights and licenses to grant the rights set out in these Terms and Conditions;
 - c. their work is original work and has not been previously published or communicated to the public;
 - d. their work does not contain any commercial or other recorded music;
 - e. they are the copyright owner or authorized licensor of all copyright works and subject matter comprising their work; and
 - f. the exercise of rights granted to the Promoter in these Terms and Conditions will not infringe the rights of any third parties.
27. The courts of New Delhi, India shall have exclusive jurisdiction to deal with and decide any dispute whatsoever arising out of this competition.
